ODLUKU O VANREDNOM RADNOM VREMENU I NERADNIM DANIMA

DECISION ON EXTRAORDINARY WORKING HOURS AND NON-WORKING DAYS

1. Imajući u vidu sezonu praznika, direktor Društva je odlučio da će tržni centar BEO Shopping Center, koji se nalazi u ulici Vojislava Ilića 141, Beograd, Republika Srbija ("**BEO Shopping Center**"), koji predstavlja osnovnu imovinu društva imati sledeće vanredno radno vreme:

1. Having in mind the holiday season, the director of the Company decides that the shopping centre BEO Shopping Center located in Vojislava Ilića 141, Belgrade, Republic of Serbia ("**BEO Shopping Center**"), which is the core property of the Company, will have the following extraordinary working hours:

- na dan **31. decembar 2025. godine i 6. januar 2026. godine**, radno vreme svih jedinica (lokali, kiosci, promo štandovi) u BEO Shopping Center će biti do 18:00h.
- na dan **1. januar 2026. godine i 7. januar 2026. godine** sve jedinice u BEO Shopping Center neće raditi zbog praznika, izuzev kazina i bioskopa koji će samostalno odrediti svoje radno vreme.
- u periodu od **2. januara godine do 5. januara 2026. godine**, radno vreme svih jedinica u BEO Shopping Center će biti redovno, izuzev bioskopa koji će samostalno odrediti svoje radno vreme.

- on **31 December 2025 and 6 January 2026**, the working hours of all business premises (units, kiosks, promo stand) in BEO Shopping Center shall be until 18:00h.
- on **1 January 2026 and 7 January 2026**, all business premises in BEO Shopping Center shall be closed due to the holidays, except for the cinema and casino which will individually determine their own working hours.
- In the period as of **2 January until 5 January 2026**, all business premises in BEO Shopping Center will work regularly, except for the cinema which will determine its own working hours.

2. U svemu ostalom Odluka o radnom vremenu ostaje na snazi.

2. In all other aspects, the Decision on working hours remains applicable.

3. Ovom Odlukom je određeno vanredno radno vreme BEO Shopping Centra tokom BEO Shopping dana, pri čemu je svaki zakupac dužan da odredi svoje radno vreme koje mora biti u

5. Ova Odluka ne zamenjuje Odluku o radnom vremenu koja je na snazi.
